It is a very historic moment. A novel Tariff concept, initiated for the 1st time Worldwide, to reduce technical losses and save energy to the tune of Rs. 1 crore/hour has borne fruit.

(This concept was recommended by the Expert Committee set up by the Ministry of Power, Govt. of India, but failed to bear fruit due to non co-operation of the erstwhile GEB a decade back.)
